We create order brochures with your Group Name and Selling Prices, you sell Poinsettias in October for December delivery to your location. You choose your selling price so your profit margin is up to you!

The Amaryllis will be delivered to you as a large bulb. This bulb is completely self-sustaining, blooming with no care whatsoever. The waxed bulb contains all the water and nutrients it needs to flower. It can stand directly on any flat surface.

TIMELINE

August/September 2020

- Contact us and commit by October 2nd, 2020. Once your group commits, we will create and send your selling materials.

Septembers/October 2020

- Campaign-sell Poinsettias and Amaryllis Bulbs to your family, friends, and neighbors. Set a goal for each seller and your group.

November/December 2020

- Submit your order and payment. Orders are due November 2nd, 2020.
- Delivery is November 30th – December 13th, 2020. We work with you to figure the best delivery date and time.

TERMS & CONDITIONS

These 2019 Terms and Conditions are effective January 1, 2020 through December 31, 2020.

Living Color Fundraiser guarantees all products.

- Living Color Fundraiser must receive 100% of the amount owed at least 3 days prior to the scheduled ship date unless prior arrangements have been made.
- Living Color Fundraiser tries to accommodate all ship date requests. To receive an order on a specific date, additional shipping charges may apply.
- Living Color Fundraiser reserves the right to deliver product in the most suitable manner. This may be via our trucks or an outside freight company.
- Claims related to plant quality or transportation damage must be reported to Living Color Fundraiser customer service within 48 hours of plant delivery. Photos are requested to aid in assessing claims when possible. The last date to submit a claim is two weeks after your delivery date
- Should your organization decide not to participate in the Living Color Fundraiser once your selling kits have shipped, you will be charged a \$50.00 printing fee.
- Any plants sold using the Living Color Fundraiser selling kits must be supplied by Living Color Fundraiser. No outside material may be substituted. Anyone found to be using outside material will be assessed a \$50 printing fee and will not be allowed to utilize any of our fundraisers in the future.
- Orders received after the due date (November 2, 2020) will not be accepted if product is not available.
 - Plant product may differ slightly from selling material and website images.
 - Minimum order is 48 items. Orders under 48 items in size will be charged a \$100 under minimum fee.
